Grade visits going on now too to promote the summer reading program. Alicia still shopping for different catalog companies, she keeps coming up with more questions. Computer upgrades need to occur, upgrade from Windows XP to Windows 8, but current computer will not support this software. New Computer towers are needed, a total of 8 will need to be purchased. Alicia waiting for quotes at this time. Alicia has a reimbursement grant for up to \$2000 from the co-op, but it has to be included in this year's budget and submitted by September to the co-op. New chairs purchased by the Friends have been delivered and are in use.

Reviewed staff evaluations. Alicia indicates Denise is has taken on a lot of the tasks Alicia felt were bogging her down, including running some reports and all computer/media use. She adds Nan is doing well when it comes to crafts, bulletin boards and organizing supplies.
